



OPPORTUNITIES IN NAKURU COUNTY

Nakuru Water and Sanitation Services Company Limited (Nawassco) is a wholly owned Water Service Provider (WSP) of the County Government of Nakuru. It is responsible for provision of water and sanitation services within Nakuru East and Nakuru West subcounties and their environs.

The County Government of Nakuru and Nawassco invites interested persons to serve as members of the board of Nawassco to represent the following stakeholders:

- (i) One Representative from local Business Community nominated by its registered body active within Nakuru city (Nakuru East and Nakuru West Sub counties)
- (ii) One Representative from a Professional Body nominated by its registered body active within Nakuru city (Nakuru East and Nakuru West Sub Counties)
- (iii) One Representative from Woman's Organizations nominated by its registered body that is active within Nakuru city (Nakuru East and Nakuru West Sub Counties)
- (iv) One Representative from Local Manufacturing Community nominated by its registered body active within Nakuru City (Nakuru East and Nakuru West Sub Counties)
- (v) One Representative of Learning Institutions (schools, colleges, research, universities) nominated by its institution active within Nakuru City (Nakuru East and Nakuru West Sub Counties)

ELIGIBILITY CRITERIA

To be eligible all persons appointed to the Board shall have a minimum of a Bachelor's degree from a recognized university in the following background.

- (i) For the Representative from Local Business Community
IT Practitioner Degree – must be in good standing of the relevant professional body and produce a letter to this effect.
- (ii) For the Representative of Professional Body
Practicing Advocate of the High Court – must be in good standing at the Law Society of Kenya and produce a letter to that effect
- (iii) For the Representative of Woman Organization
Human Resource degree and practitioner – Must be in good standing with the Institute of Human Resource Management
- (iv) For Representative from Manufacturing Community
Registered Engineer – Must be in good standing at the Institute of Engineer of Kenya

- (v) For Representative of Learning Institution
CPA Experience in Accounting/Finance Must be in good standing at the Institute of Certified Public Accountant of Kenya and produce a letter to that effect.
- (vi) Must have a minimum of seven years working experience in the core profession of the person or have run a registered own enterprise for a minimum of seven years
- (vii) Must meet the leadership and integrity criteria under the Constitution Chapter 6 and meets the Fit and Proper Test Criteria from WASREB.
- (viii) Must have attended a Corporate Governance training in a recognized institution

Interested persons should submit their application and Curriculum Vitae (CV) indicating the local stakeholder group they belong to and the area of residence within the service area of the company including certified copies of academic testimonials, professional certificates, national identity card, two (2) colored passport size photos.
